1. This agreement constitutes an order for wedding portraiture services, including the taking of wedding pictures as agreed to by both parties: DNS Technology Consultants Inc. (DNSTC) and Contracting Party (Client). Unless otherwise specified, it is understood that any and all rights to proofs, final or sample prints, thereof shall remain the property of DNSTC and may be used for advertising, display or any other purpose thought proper by the DNSTC.

2. If Photographer cannot perform this Agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to Photographer's illness or injury, then DNSTC will return all fees to the Client(s) but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Photographer. Client(s) agree that an entire wedding cannot be replicated, reenacted or repeated for the purpose of a re shoot and limits DNSTC's liability to the amount paid under this contract.

3. It is understood and agreed that DNSTC will be the exclusive official photographer and others taking photographs at the wedding will be permitted only at our discretion.

4. DNSTC does not guarantee any specific poses and/or effects, but will produce photographs that timing, lighting, weather, building characteristics, church (ceremony location) rules, interference of other cameras, and wedding participant/attendee cooperation permits.

5. The client agrees to purchase at least one (1) wedding package offered by DNSTC to coincide with photographs taken on the wedding date.

6. On signing of this agreement by both parties hereto, DNSTC will reserve the time agreed upon and will not make another reservation for the specific time frame. For this reason, all deposits are non-refundable even if the date is changed or if the wedding becomes cancelled for any reason.

7. The service fee of \$300.00 includes up to 10 hours of photography. A deposit of \$150.00 is due at the signing of this agreement, with a further payment of all balances be paid prior to receiving any items from DNSTC. No photography will take place and no rights are granted until a timely deposit is made in full. Late payment fees and returned check fees may apply. The deposit (retainer) fee is non refundable in case of cancellation or date change by client.

I / we, the undersigned Contracting Party, hereby warrant that I am / we are competent to contract in my / our own name(s). I / we confirm that I / we have read the herein agreement prior to its execution and I / we are fully familiar with the contents thereof. This agreement shall be binding upon us and our heirs, legal representatives and assigns. And, we certify that we will receive a complete copy of this agreement with all blank lines completed.
